

SCUF x ORACLE RED BULL SIM RACING SWEEPSTAKES TERMS AND CONDITIONS

The Sweepstakes is subject to these terms and conditions (the “Terms and Conditions”), and by entering, a participant (“Participant”) agrees to be bound by these Terms and Conditions and the decisions of Corsair, which are final and binding in all respects.

ALL EMAIL ADDRESSES PROVIDED TO CORSAIR TO REGISTER FOR THIS SWEEPSTAKES WILL ALSO BE SHARED WITH RED BULL RACING LIMITED (“RED BULL RACING”) FOR THEIR MARKETING USE. PROMOTION ENTRY PERIOD:

The Sweepstakes begins on November 18, 2024, at 12:00AM Eastern Time and ends on December 3, 2024, at 11:59PM Eastern Time (the “Promotion Period”) unless ended earlier by Corsair. Corsair’s computer is the official timekeeping device for participation in the Sweepstakes.

ELIGIBILITY
